IORANDUM OF UNDERSTANDING

Between

International Hellenic University (IHU)

and

CITEVE - CENTRO TECNOLÓGICO DAS INDÚSTRIAS TEXTIL E DO VESTUÁRIO DE PORTUGAL (CITEVE)

This Memorandum of Understanding ("Agreement"), effective as of the last dated signature below (the "Effective Date"), is made by and between the International Hellenic University ("IHU"), located at 14th km Thessaloniki- N. Moudania Road, Thermi Thessaloniki, 57001, and Centro Tecnológico das Indústrias Têxtil e do Vestuário de Portugal (CITEVE) located at Rua Fernando Mesquite, 2785, 4760-034 Vila Nova Famalicao, registration number 502 201 886. CITEVE is represented by Antonio Rui Sousa Dias Amorim and Antonio Braz dos Santos Costa, in their capacity as President of the Board of Administration and General Director, respectively, with powers of representation.

IHU and CITEVE referred to individually as "Party" and collectively as "Parties."

In order to realize a higher level of understanding between the two Parties IHU and CITEVE hereby agree to initiate cooperation between the two Parties.

1. Purpose of the Memorandum of Understanding.

The parties are interested in strengthening collaboration to exchange best practices, identify common goals and initiate joint initiatives, within the framework of:

- Supporting education and training providers in updating and modernising so that they can better respond to companies' skills needs;
- Establishing cross-sectoral competences and exchanging best pedagogical practices applied to the T&C sector;
- Encourage the development of mentoring programmes through guidelines and case studies;
- Encourage and facilitate internship for undergraduate students in the specialised research and development centres and private industries, whenever possible;
- Formulate and submit joint proposal of mutual interest for fundraising;





2. Information Sharing and Confidentiality

Each party undertakes to respect the confidentiality of the other party's confidential information. Each party is to treat all confidential information owned by the other party which is specifically designated as confidential information in writing as confidential, and shall not disclose or permit the same to be disclosed to a third party without the written authorization of the owner of that confidential information. Each party may request the other parties to enter into a confidentiality deed prior to the disclosure of confidential information.

3. Coordinators.

Each Party shall designate a coordinator to oversee and facilitate the implementation of this Memorandum of Understanding
